VeloPark House Rules

Debrecen

Welcome to our facility! This house rule sets forth the behavior expected of individuals within the Park and prescribes the requirements for the proper use, protection, and preservation of VeloPark. It is in our mutual interest to ensure that users spend their time in the VeloPark in a safe and cultured environment. Disturbances will result in warning, followed by administrative or criminal proceedings, and compensation claims against those causing damage.

Compliance with these house rules is in our shared interest, and we kindly request our guests' cooperation.

Thank you in advance for your cooperation, and we look forward to welcoming you to our facility and events!

- 1. The facility and its events can be visited at one's own risk.
- 2. Children under 12 years old may only stay in the facility under adult supervision.
- 3. We cannot assume responsibility for personal belongings left in the VeloPark area.
- 4. It is forbidden to bring animals, weapons, or objects resembling weapons, or any other items or substances dangerous to life, physical safety, health, or public safety into the VeloPark area.
- 5. Access to the sports area is only allowed with a bicycle appropriate for the specific track. Scooters, small motorcycles, roller skates, skateboards, or other motor-powered one- or two-wheeled vehicles are only allowed up to the parking area.
- 6. Smoking is prohibited throughout the entire VeloPark area. Smoking is only permitted outside the premises, while respecting the safety of the forest and buildings.
- 7. The use of cycling tracks and circuits is only allowed with the use of a bicycle helmet.
- 8. The road circuits, unless otherwise marked, must be used in a counterclockwise direction (left-hand circuit).
- 9. Tracks are exclusively for cycling; walking and running on them is strictly prohibited!
- 10. Sports organization training sessions take precedence. To avoid obstructing training, usage of the tracks is only permitted with the present coach's permission and in accordance with their instructions.
- 11. The parking lot is reserved exclusively for VeloPark guests and Debrecen Sports Center staff.
- 12. The issuance of sports equipment owned by VeloPark requires a receipt of acknowledgment, and the person receiving the equipment is responsible for it.
- 13. If a visitor does not cease using the referenced equipment during an event after being requested by the staff, our colleagues may ask the visitor to leave the event venue.

- 14. Image, sound, and video recordings may be made throughout the entire VeloPark area, in which any visitor may appear, but no claims can be made against Debreceni Sportcentrum Kft, the organizers, the creators of the recording, or its lawful users.
- 15. Recording images and/or sounds at events with any device is prohibited, except as described in point 14. (This includes images and/or sound recordings made with mobile phones.) Failure to comply with this rule may result in consequences for copyright and neighboring rights violations.
- 16. Persons who are visibly under the influence of alcohol or drugs are not allowed to visit the facility.
- 17. The security service and the staff of the operating company are authorized to ask visitors under such influence to leave the facility.
- 18. Guests are required to use the VeloPark premises and cycling tracks as intended, keep the environment tidy, and preserve and handle the equipment and furnishings in the building according to the rules.
- 19. In the event of an emergency (e.g., natural disaster, fire, bomb threat, etc.), the visitor must precisely follow the instructions of the VeloPark staff and act according to the building's evacuation plan.
- 20. A visitor who violates these house rules may be temporarily or permanently banned from the VeloPark after a warning, and legal proceedings may also be initiated against them. The person violating the house rules, or the person responsible for the one violating the house rules, is liable for any damage caused by the violation. If the violation of the house rules also constitutes a violation of the law, the person violating the house rules or the one responsible for the violator is liable for the legal consequences and any legal sanctions that may apply.
- 21. These house rules take effect on June 1, 2022, and are valid until revoked.
